On Wednesday, June 17, 2009, at approximately 5:07 p.m., the Lakeland Police Department responded to 1017 Griffin Road #219 in reference to shooting that had just occurred.

Upon the arrival of the officers at the residence, the victim, Stephanie Joseph was found in the bathtub with a gunshot wound to the head. Stephanie Joseph was pronounced dead at the scene by Polk County EMS personnel.

The defendant, Christopher Lee Chambers Jr. did the unlawful killing of a human being, when he perpetuated an act imminently dangerous to the decedent and evincing a depraved mind regardless of human life, although without any premeditated design to effect the death of the decedent by going into his bedroom and removing a Glock 19, 9mm handgun from a storage case that was hidden under the bed. The defendant then removed said handgun from the storage case and approached the decedent who was in the bathroom taking a shower at the time with said handgun in his right hand. The defendant then lifted said handgun up in a horizontal position pointing the handgun at the decedent's face. The defendant then made an accusation toward the decedent in reference to her being unfaithful and pulled the trigger on the handgun shooting the decedent in the face causing her death. The defendant did make several spontaneous statements about shooting the decedent and also gave a taped statement admitting to shooting the decedent in the face.
