PROBABLE CAUSE CONTINUATION

On 2/3/2010, at approximately 2:26 p.m., the defendant was traveling westbound in the 1300 block of E. Main Street, Lakeland, Florida, when he was clocked speeding and a traffic stop was attempted. The defendant refused to stop traveling west for approximately one half of a mile before turning North onto Lake Parker Avenue. The defendant continued traveling north for approximately 3/4 of a mile with a marked Lakeland Police Department vehicle with the emergency lights activated following. The defendant continued traveling north and refused to stop even after the officer manually activated his siren. At the intersection of N. Parker Avenue and Parker Street, the defendant turned east and immediately turned south stopping in an open field parking area at the southeast corner of N. Parker Avenue and Parker Street. Patrol Officer Brown, dressed in a police uniform approached the driver side of the defendant's vehicle and repeatedly requested the defendant's driver's license, registration, and insurance card. After Officer Brown repeatedly requested the defendant's driving paperwork and those requests were ignored by the defendant. The defendant's continued to be noncompliant to the officer's request, Officer Brown verbally advised the defendant he was under arrest for resisting an officer and opened the driver side door. At this time the defendant did knowingly and willfully resist, obstruct, or opposed the officer who was legally authorized to execute the lawful execution of any legal duty and the defendant began doing violence to the officer by punching, kicking, and striking the officer in an attempt to avoid arrest. When the defendant could not thwart the officers attempt to arrest him, the defendant did intentionally or knowingly cause great bodily harm, permanent disability, or permanent disfigurement using a deadly weapon, that being a motor vehicle as instrumentality by starting said vehicle, a full-size Dodge pickup truck. The defendant did grab onto Officer Brown in an attempt to trap him to the vehicle as the defendant started said vehicle and placed it into drive while accelerating toward two parked vehicles. The defendant used the vehicle in an attempt at causing great bodily harm to Officer Brown who was dragged on the driver side of the vehicle for approximately 20 to 30 feet. Officer Mosser feared for Officer Brown's safety and fired his service weapon at the defendant as he was dragging Officer Brown through the parking lot. The defendant swerved to the right and released Officer Brown from his grasp, causing Officer Brown to be ejected and collide into the rear of a parked vehicle. The defendant continued to accelerate at high rate of speed turning North onto N. Lake Parker Avenue before turning West onto E. Memorial Blvd. When the defendant turned west onto E. Memorial Blvd., the defendant was traveling west in the eastbound lane for traffic while Officers Brown, Mosser, and Maddox were attempting to stop the defendant in their marked Lakeland Police Department patrol vehicles utilizing both lights and siren. The defendant did willfully refuse to stop the vehicle and elude officers while officers were attempting to lawfully stop him as the defendant's actions demonstrated a wanton disregard for the safety of persons or property on E. Memorial Blvd., as the defendant fled West in the eastbound lane for traffic. The defendant's actions were captured on video from the marked patrol vehicles onboard video systems.

Once the defendant was in custody, It was determined that he is currently on active felony probation with a termination date of 11/20/2010. The defendant is on probation for the felony of aggravated assault with a weapon with no intent to kill. The defendant's probation status was activated on 11/21/2007 and he is currently listed with the Florida Department of Corrections.
