

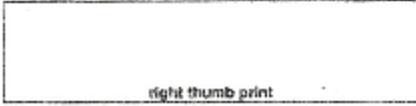

PROBABLE CAUSE CONTINUATION**

On February 23, 2010, this Detective was called out to investigate a Strong Armed Robbery which occurred in the area of 5011 Williamstown Blvd., Lakeland, Polk County, Florida. Incident occurred at approximately 2300 hrs. on February 22, 2010. The Defendant and co-occupants of a 06' Nissan Altima were loitering in the area of 5011 Williamstown Blvd. when the Defendant exited the vehicle and confronted the victim. The Defendant ran up to the victim and forcibly took a toiletry bag that belonged to her boyfriend; the Defendant assumed the bag was the victim's purse. The victim advised she attempted to prevent the Defendant from taken the bag, but the Defendant was bigger, stronger and overpowered her. The Defendant ran back to the vehicle, entered the driver's side rear seat of the vehicle and the vehicle fled from the area. The victim notified her boyfriend who chased after the vehicle in his white pickup truck along with his roommate.

While being chased by victims Williams and Boyd, the Defendant intentionally produced a 22 caliber rifle from the driver's side rear passenger window and fired several shots at victim Williams' vehicle. The suspect vehicle was rendered inoperable when it hit a curb at a high rate of speed; all occupants of the vehicle fled on foot. The toiletry bag and the rifle were left in the vehicle, which was impounded by Lakeland Police Department. Patrol officers apprehended the Defendant and [REDACTED] adjacent neighborhood. Victim Amanda Rivas was transported to the arrest location and positively identified the Defendant Miguel Rodriguez as the suspect who committed the strong arm robbery against her.

Post Miranda, the Defendant was interviewed two separate times. During the initial interview, the Defendant denied any involvement with the Robbery or the Snooding and stated he was not even present during the incident. The Defendant later told this Detective he had a talk with God, and he wanted to tell the truth. The Defendant was interviewed a second time and he admitted to taking the victim's bag without her permission. The Defendant stated he confronted the victim and told her to "Give me your purse!" The Defendant stated he snatched the bag from the victim's hands and ran back to the vehicle. The Defendant stated that when they were being chased by victim Williams and Boyd,
